Client accepts and agrees to be obligated to all of the representations, terms and conditions contained within the existing account documentation, Client Agreement, any other Agreement, Authorization or Acknowledgement of Receipt of Risk Disclosures previously agreed to with MF Global or which have been assigned to MF Global.

The undersigned further represents that any additional account opened pursuant to this Letter of Request is identical in all respects to the client's existing account, except as otherwise disclosed to MF Global in writing, and further represents that there have been no material changes in Client's personal information or financial condition as previously disclosed in existing account documentation.
